As per the RfP Notification, I/we accept the following terms and conditions:

If during the aforesaid period of 15 months the said Farm Machinery and Agro- Processing Units be discovered not to conform to the description and quality aforesaid not giving satisfactory performance or have deteriorated, and the decision of the Buyer (farmer) in that behalf shall be final and binding on the Bidder and the Buyer (farmer) shall be entitled to call upon the Bidder to rectify the _____ (____ - Schedule) or such portion thereof as is found to be defective by the Buyer (farmer) within a reasonable period, or such specified period as may be allowed by the Buyer

- iv. In case of a material breach that was not remedied within 45 days, the BUYER (FARMER) shall, having given the right of first refusal to the BIDDER be at liberty to purchase, manufacture, or procure from any other source as he thinks fit, other _____ (____ - Schedule) of the same or similar description to make good:-
 - a Such default.
 - b In the event of the contract being wholly determined the balance of the _____ (____ - Schedule) remaining to be delivered there under.
- v. Any excess of the purchase price, cost of manufacturer, or value of any _____ (____ - Schedule) procured from any other Manufacturer as the case may be, over the contract price appropriate to such default or balance shall be recoverable from the BIDDER.

30. **Force Majeure Clause.**

- i. Neither party shall bear responsibility for the complete or partial non-performance of any of its obligations (except for failure to pay any sum which has become due on account of receipt of goods under the provisions of the present contract), if the non-performance results from such Force Majeure circumstances as flood, Fire, Earth Quake and other acts of God as well as War, Military operation, blockade, Acts or Actions of State Authorities or any other circumstances beyond the parties control that have arisen after the conclusion of the present contract.

If the impossibility of complete or partial performance of an obligation lasts for than 6 (six) months, either party hereto reserves the right to terminate the contract totally or partially upon giving prior written notice of 30 (Thirty) days to the other party of the intention to terminate without any liability other than reimbursement on the terms provided in the agreement for the goods received.

33. **Quality Assurance:** The item should be of the latest manufacture, conforming to the current production standard and having 100% defined life at the time of delivery.

34. **Claims:** The following Claims clause will form part of the contract placed on Successful Bidder:-
- i. The claims may be presented either: (i) on quantity of the _____ (____ - Schedule), where the quantity does not correspond to the quantity shown or (ii) on quality of the machines and equipment, where quality does not correspond to the quality mentioned in the contract.
 - ii. The quantity claims for deficiency of quantity shall be presented within 45 days of completion of inspection and acceptance of goods. The quantity claim shall be submitted to the successful bidder.

 - When the OEM/ Manufacturer/Importer/ MOU holder fails to honor any part of the contract including failure to deliver the contracted _____ (____ - Schedule) /render service in time.

- Any special circumstances, which must be recorded to justify the cancellation or termination of a contract
39. This approval of Rate Contract holder is being issued with no financial commitment and the Department of Agriculture, Government of Karnataka reserves the right to change or vary any part thereof at any stage. The Department also reserves the right to withdraw the empanelled firm, should it become necessary at any stage.
40. Payment Terms: No advance payment shall be made. The payments could be made through ECS/NEFT/Cheque mechanism, wherever feasible. The supply bill/invoice should be in the name of empanelled firms only.
41. The empanelled firms who do not supply the machinery as per the indent placed from the Taluka ADA office or concerned department officers during the Agreement period of the current RfP will be blacklisted for subsequent 03 years.
42. Shall agree and abide to all the terms and conditions given in the RfP.
43.
